**Minutes of the Selection Committee Meeting held on 27.06.2024 & 28.06.2024
for the post of Lecturer (Audio/Speech Pathology) at AYJNISHD(D),
Mumbai.**

The Ali Yavar Jung National Institute of Speech and Hearing Disabilities (D), AYJNISHD(D), Mumbai has advertised 04 posts of **Lecturer (Audio/Speech Pathology)** vide advertisement notification published in Employment News 21 - 27 October 2023. Out of the 04 posts, 03 posts are 'Unreserved' (UR) & 01 post reserved for 'Economically Weaker Section (EWS)'. Among the 04 posts, any 01 post is reserved for Locomotor Disability. However, no eligible candidates were shortlisted for either EWS or Locomotor Disability.

In response to the advertisement, the Institute has received 68 applications. A Screening Committee was constituted to identify the eligibility of the applicants and the first list was uploaded on the website. Subsequently, representations were received & same were reviewed by the Screening Committee. Out of the 68 applications, following 30 candidates were short listed.






